**BUYER'S BROKER/AGENT PARTICIPATION PLAN**

The registration must be received at Tammy Miller Auctions, Attention: Tammy Miller, at least 48 hours prior to auction day – NO EXCEPTIONS to this procedure and no oral registrations will be accepted. UNDER NO CIRCUMSTANCES WILL BROKER/AGENT REGISTRATION BE ALLOWED ON THE DAY OF THE AUCTION. In addition, to qualify for a commission, the broker/agent MUST accompany their prospective purchaser to any showings of the property their prospective purchaser chooses to attend and the broker/agent MUST attend the auction with their prospective purchaser. Commissions will be paid only if the property closes. A commission on a property will be paid only to the first broker/agent registering a prospective purchaser and only when the broker/agent's prospective purchaser is not already on the marketing list of Tammy Miller Auctions or has previously contacted the seller or Tammy Miller Auctions. A BROKER/AGENT CANNOT ACT AS A PRINCIPAL AND BROKER/AGENT ON THE SAME TRANSACTION.
